***ENROLLMENT PROCESS:***

If you are an early arrival international student this summer 2008 and wish to be enrolled early in the Suffolk University Health Insurance Plan with the above effective dates, please go to [www.universityhealthplans.com](http://www.universityhealthplans.com), click on Suffolk University, select Student Insurance Plan, and click on International Early Arrival Summer 2008 Enrollment Form. The **deadline to enroll** for international students (undergraduate and graduate) is **7/24/08** and for international law students is **7/13/08**.

***BENEFIT SUMMARY:***

The program does not require you to use a preferred provider. If you utilize PHCS or CHP providers, you will receive maximum benefits and lower your out-of-pocket payments. The policy will pay for Covered Medical Expenses incurred by a Covered Person due to a covered Accident or covered Sickness not to exceed an aggregate maximum benefit of \$50,000 per Accident or Sickness, except as specifically stated.		
Coverage: Reimbursement is based on the Negotiated Charge for In-Network Preferred Providers or Reasonable and Customary based in accordance with data provided by Nationwide for Out-of-Network Non Preferred Providers.
