We are pleased to provide you with this overview of the Drew University Graduate Student Health Insurance Plan (SHIP). This ACA-compliant plan includes:

- Coverage while at school and at home
- Comprehensive coverage both for emergency and non-emergency situations
- Access to the Cigna PPO network

***This Plan is paired with the Cigna Network. Note that the benefits are not insured by Cigna or affiliates.***

These services are not part of the student health insurance plan underwritten by National Guardian Life Insurance Company. This plan also offers the following value-added service:

## Drew University Graduated Student Insurance Requirements

Matriculated students (accepted in a degree granting program) who are at least part-time, or those who have completed coursework and are registered for maintaining matriculation status, are eligible to purchase the plan. Matriculated students who are not currently registered, or who have requested a leave of absence, are not eligible to enroll in the plan.

## 2017/2018 Waiver Deadlines

Students who already have health insurance may waive the student insurance through the online form in Treehouse. Log into the student section of Treehouse and click "Waive or Enroll in student Health Insurance." Under the Bills, Financial aid & Student Employment heading. Students not enrolling in the school sponsored plan must provide evidence of other comparable insurance.

Students that fail to enroll or waive the plan will automatically be billed for the student insurance plan on their fall semester tuition bill.
