# 2021–2022 Student Injury and Sickness Insurance Plan for Johnson & Wales University

### Who is eligible to enroll?

All registered undergraduate day students, both domestic and international; all students enrolled in the Physician's Assistant Program, on-campus Occupational Therapy Program, Addiction Counseling or Clinical Mental Health Counseling master's degree programs as well as international graduate/doctoral students attending Johnson & Wales University and taking credit hours (excluding full-time Johnson & Wales employees) are eligible and enrolled in the plan on a hard waiver basis.

**Medical Leave of Absence Eligibility requirements:** Johnson & Wales University allows eligible registered undergraduate day students, both domestic and international; all students enrolled in the Physician Assistant Program, on-campus Occupational Therapy Program, Addiction Counseling or Clinical Mental Health Counseling master's degree programs as well as international graduate/doctoral students attending Johnson & Wales University and taking credit hours (excluding full-time Johnson & Wales employees) to continue enrollment under the Johnson & Wales University Student Injury and Sickness Insurance Plan while on an approved medical leave of absence for a maximum of one semester. Student must have been enrolled in the University's Student Injury and Sickness Insurance Plan the previous semester to be eligible. Student must have the medical leave of absence form signed by the Director of the Student Health Center or the Counseling Center or their designee. The Student must intend to return to the University and remain a degree-seeking candidate.

The student (Named Insured, as defined in the Certificate) must actively attend classes for at least the first 31 days after the date for which coverage is purchased. Home study, correspondence, and online courses do not fulfill the eligibility requirements. The Company maintains its right to investigate eligibility or student status and attendance records to verify that the Policy eligibility requirements have been met. If and whenever the Company discovers that the Policy eligibility requirements have not been met, its only obligation is refund of premium.

### **Exclusions and Limitations**

No benefits will be paid for: a) loss or expense caused by, contributed to, or resulting from; or b) treatment, services or supplies for, at, or related to any of the following:

- 1. Learning disabilities.
  - This exclusion does not apply to benefits specifically provided in the Policy or to any screening or assessment specifically provided under the Preventive Care Services benefit.
- 2. Circumcision, except as specifically provided for a Newborn Infant during an Inpatient maternity Hospital stay provided under the Benefits for Maternity Expenses.
- 3. Cosmetic procedures, except:
  - To treat or correct Congenital Conditions of a Newborn Infant and Adopted or Foster Child.
